Student Dress Code

The Hatton Vale State School "Student Dress Code" provides guidance to our school community on the agreed uniform and standards for student personal presentation.

The uniform dress code reinforces in students a pride in their own appearance, instils a strong sense of belonging within the Hatton Vale State School community, and assists in developing pride in representing the school. Issues of equality, health and safety, and expense are also factors that contribute to the establishment of the following *Student Dress Code*.

Any variation to the approved dress items must gain prior approval from the principal.

Aim

The aim is to:

- Promote equality amongst all students.
- Develop a sense of pride in, and identification with our school.
- Provide durable clothing that is cost effective and practical for our school environment.
- Maintain and enhance the positive image of the school in the community.

Benefits

Hatton Vale State School believes as a school community that there are benefits in students following an agreed dress code. These benefits include:

- 1. Appropriateness: Guarantee that all students are dressed appropriately for all school activities.
- 2. **Safety**: Promote a safe environment for learning by enabling ready identification of our students in the school grounds; while travelling to and from school and on excursions.
- 3. **Equity**: Promote an effective teaching and learning environment by eliminating the distraction of competition between students to wear more expensive or fashionable clothing, and avoid the pressure on parents to purchase fashionable clothing.
- 4. **Expense**: To minimise the cost to families.

Endorsement

In line with the Education General Provisions Act 2006, staff, the School Council and the Parents and Citizen's Association have endorsed the following *Student Dress Code* for all students.

Hatton Vale State School has a dress standard in relation to:

- Clothing worn by students, including headwear and footwear
- Students' personal grooming and hygiene

The Hatton Vale State School student dress code reflects school community standards and is consistent with occupational health and safety and anti-discrimination legislation.

Uniform Shop

The Uniform Shop is on the Hatton Vale State School campus and all items are only available from school. The Uniform Shop operates: Monday – Thursday

Additional hours will be advised during peak times.

Second hand uniforms may be purchased from the Uniform Shop, subject to availability.

Red and Gold panelled short sleeved, sublimated, polo shirt with school logo on right chest, and Patterson house logo on the back. Green and Gray panelled short sleeved sublimated, polo shirt with school logo on right chest, and McKellar house logo on the back.

Yellow and Black panelled short sleeved sublimated, polo shirt with school logo on right chest, and Lawson house logo on the back.

Blue and White panelled short sleeved sublimated, polo shirt with school logo on right chest, and Franklin house logo on the back.

Students will be able to wear their house shirts on the following days:

- Athletics, cross country and swimming carnivals
- Intra and inter-school sports' days
- Whole school designated day on Wednesday

Prep – Year 6 FOOTWEAR

Shoes

The only acceptable shoes are black school shoes and/or predominantly black sports joggers/trainers, with black or white laces. White joggers are also acceptable.

Hi-top and mid-cut shoes are not acceptable.



Socks

Plain white socks with gold/green bands, or plain white socks. Black socks may also be worn with black shoes.

Girls and Boys Uniform Students are required to wear the approved uniform daily. ✓ Sports uniform for physical education, sports days and any other days designated by the school. Board or cargo shorts and jeans are unacceptable. Jumpers and Jackets Students are required to wear the approved winter uniform. Undergarments Bottle green tights and long sleeve shirts only.	Any undergarments must not be worn over the school uniform or visible except for the school approved bottle green clothing. Hats Hatton Vale State School is a sun safe school and adheres to the guidelines of the Queensland Cancer Society. Students are required to wear the approved sun safe school reversible bucket hat.	Baseball style caps are not permitted.	 Students who do not have the appropriate sun safe hat will be excluded from activities in the sun. They will be required to stay in shade areas. Students who do not have the appropriate sun safe hat will be ineligible to attend off campus activities in the sun.

Footwear and Socks Enclosed shoes ensure maximum safety for everyone. • Students are required to wear the approved footwear. Fully enclosed. Predominantly black school shoes or sports joggers/trainers with black or white shoe laces. • Plain white socks are preferred, although black is acceptable.	 Multi-coloured, fluorescent-coloured sports shoes, socks or shoelaces are not permitted. 1. Shoes with high heels or platforms, thongs and slip-ons are unsafe and not permitted. 2. Hi-top or mid-cut shoes are not permitted. 3. Bright, multi-coloured socks are unacceptable. 4. Footwear must be worn at all times unless the activity necessitates bare feet, or the activity prohibits footwear e.g. swimming 	The following consequences will apply if a student does not wear the appropriate footwear. ✓ Student will be given a verbal warning. ✓ Parents will be notified for consistent breaches of the dress code.
Jewellery Students may wear the following approved items: • Watch. • Small plain sleepers or stud earrings. • Medical alert bracelet or necklace. • Items of significant religious or cultural belief to be worn under clothing.	 Other jewellery may be unsafe and become caught in play equipment or come in contact with another student causing injury. Visible body piercing other than ears is not acceptable. 	 A student wearing inappropriate jewellery will be required to remove the item and if necessary, give it to the teacher for safe keeping. Repeat offenders will be warned and the inappropriate item will be confiscated and parents are required to collect the item from the school.
Nail Polish / Make-up / Temporary Tattoos Students are not permitted to wear clearly identifiable nail polish, fake nails, cosmetic make-up or have temporary tattoos.	Temporary tattoos are not acceptable.	 Students wearing coloured nail polish will be asked to remove it before returning to school the next day. Parents are contacted and requested to remove the make-up on their child. Students will be required to cover up the tattoo until it fully fades away.
Hair Conservative hairstyles and natural colour.	 Long hair is to be tied back, braided or plaited. This will minimise the transfer of head lice. This also applies to boys. (below collar length is the general requirement for tying back.) Extreme hairstyles (e.g., tracks, spikes, mohawks) or extreme colours (e.g., green, pink or purple rinses) are not permitted. 	 Students will be required to tie back long hair. Extreme hair styles and dyed hair will result in a breach.
Helmet Students riding bikes or scooters are required to wear a helmet.	All students riding to and from school are required to wear a secured bicycle helmet.	Students who fail to wear a helmet will not be permitted to ride their bicycle/scooter to school.

Consequences Of Non-Compliance

1ST **Offense:** Warning and Reminder.

2ND Offense: Dress Code Non-compliance breach note sent home.

3RD Offense: Referred to Deputy Principal – Parents are contacted by the Deputy Principal to discuss reasons and

reinforce school expectations.

4TH Offense: Referred to Deputy Principal – Possible suspension (continuous non-compliance).

Notes

- 1. Non-compliance of the Student Dress Code associated with genuine financial hardship or medical issues or a disability will be considered on a case-by-case basis. The principal or their nominee is the sole authority in this matter.
- 2. Parents and Carers will be notified in writing if their child consistently breaches the school's student dress code.
- 3. This policy will be reviewed as part of the Department of Education and school review cycles.
